

All,

I just wanted to take the time to send a follow up email to our cemetery funds meeting on June 2nd. If there is something that I missed or that I translated incorrectly please let me know.

At the meeting we discussed the different lines that make up the Cemetery Trustees Budget. We established that there is money for mowing (done by an independent contractor), private cemetery care (abandoned cemeteries), water, general supplies, grounds maintenance (grub treatments), care of trees and monument maintenance (Tom Duffy, stone cleaner).

Alan & Peggy, I did not clarify with you who the top two lines for wages and applicable taxes pertains to. Do you mind explaining that?



We discussed the 4 cemetery funds that are listed on the MS-9, <u>two capital reserve</u> <u>funds</u> and <u>two trust funds</u>. We discussed how the Cemetery Maintenance Expendable Trust Fund (formerly known as the 1977 General Cemetery Care Fund) currently listed under the trust funds would be moved to the capital reserve section of the MS-9. We also spoke of how that money would be moved out of the Fidelity Common Trust Fund and into the Fidelity Common Capital Reserve Fund, due to the 2022 warrant article changing its purpose. We reviewed the fund snapshots for the four funds and discussed some changes that were necessary, see below.

What was of greatest importance with the Pickering Cemetery Trust Fund was that it is **<u>NOT</u>** expendable and that we are currently journaling income each month to principal until we can restore the \$3,500.00 principal balance.

	Abandoned cemetery of the Pickering family located on Newington Development Trust parcel deeded to the Town in 1993. The Olive Garden Reaturant gave a 25,500 check to the Trustee of Trust Funds to establish a trust fund to care for the cemetery. There is controvery over whether the \$2,500 matching funds were reached/deposited by the Town. A 2002 email from Charlie Smath to Tom Larging establish the match was in kind services not money. Another donation of \$1,000 was to have been received by Th Red Lobater. Various conversations in 1993 and 2002 about donations received for this fund, unknown whether they were deposited into this hund.

You will continue to see this fund reported on your MS-9 through year-end 2022 with a zero balance. It will drop off on January 1, 2023. What was of greatest importance with the Cemetery Capital Reserve Fund was that the Cemetery Trustees no longer wish to pursue retrofitting the old receiving tomb. This fund has similar wording to the Cemetery Improvements Capital Reserve Fund and now that the Cemetery Trustees do not want to pursue the retrofitting, l would recommend a warrant article in 2023 to close this fund and transfer the balance to the Cemetery Improvements Capital Reserve Fund (I have set a reminder to bring this topic back up in December). I have changed the fund purpose as instructed, a new snanshot fund hae heen attached to thie email.

After review of the four funds that you hold we discussed what types of things the Cemetery Trustees might be thinking of using the two cemetery improvement funds for. Alan and Peggy mentioned fencing, tree removal, weed whacking, stone repairs, eastern end needing resodding and roads being put into the town cemetery. These will be important discussions to keep going between your two groups.

We reviewed that Newington has no flower or flag funds and there are no special monuments, gazebo's, benches, etc that are to be maintained. We discussed that there is not a capacity issue at this time so there is no need to discuss a potential warrant article to establish a cemetery expansion or development fund.
